

FIRST AID

DIRECTIONS FOR USE:

READ ENTIRE LABEL - USE IN ACCORDANCE WITH LABEL INSTRUCTIONS

PRECAUTIONS AND NOTICES: Avoid breathing dust. May cause eye and skin irritation. Avoid contact with eyes, skin and clothing. Dust mask, eye protection and chemical resistant gloves are recommended. Applicator should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove PPE after handling this product.

APPLICATION AND MIXING: Apply with a hand or power operated sprayer. Add 1/2 the required amount of water to the tank. Add the appropriate amount of product. Shake or agitate to thoroughly mix. Add the remaining amount of water to the mixture. **IMPORTANT: THIS PRODUCT SETTLES QUICKLY.** Shake or agitate thoroughly before every use and frequently during use to maintain proper suspension. After use, rinse the tank with clean water and flush the valve and hose. Prepare no more solution than what is required for the day. Do not store mixture overnight.

APPLICATION RATES: Use from one to three level scoops of EcoSafe WPX per 1000 sq ft depending on pest severity and desired residual. Mix in a sufficient volume of water to cover 1000 sq ft. For indoor use, apply up to 1 gallon of spray liquid per 1000 sq ft. For outdoor application, use up to 5 gal of spray liquid per 1000 sq ft, or as needed to ensure adequate coverage. See chart on this label for active ingredient percentages at various mix and application rates.

GENERAL PESTS INCLUDE BUT ARE NOT LIMITED TO: Ants, Asian lady beetles, Bat bugs, Bed bugs, Biting flies, Blow flies, Bottle flies, Boxelder bugs, Carpenter ants, Carpenter bees, Carpet beetles, Cigarette beetles, Clothes moths, Cluster flies, Cockroaches, Crickets, Darkling beetles, Dermestids, Drain flies, Drugstore beetles, Earwigs, Firebrats, Fleas, Flour beetles, Fruit flies, Fungus gnats, Gnats, Ground-nesting wasps and bees, Hornets, House flies, Indianmeal moths, Other pantry beetles & moths, Kudzu bugs, Lice, Midges, Millipedes, Mites, Mosquitoes, Phorid flies, Scorpions, Silverfish, Spiders, Springtails, Stable flies, Stink bugs, Ticks, Wasps, Wood-destroying beetles, and Yellow jackets.

TREE, SHRUB AND VEGETATION PESTS INCLUDE BUT ARE NOT LIMITED TO: Adelgids, Aphids and their eggs, Armyworms, Bagworms, Beetles, Billbugs, Chiggers, Chinch bugs, Cutworms, Elm leaf beetles, Grasshoppers, Grubs, Japanese beetles, Lace Bugs, Leafhoppers, Mealybugs, Mites, Mole crickets, Sawfly larvae, Scale insects, Sod webworms, Tent caterpillars, Thrips, and Whiteflies and their eggs.

USE SITES: In and around residential and commercial structures, agricultural buildings and other man-made structures, drains and sewers, food service, handling and/or processing establishments, Turf sites include but are not limited to: lawns, landscape beds, parks, playgrounds, and golf courses. Transport vehicles including: trucks, trailers, trains, buses, boats, and other cargo vessels. Do not use on food or feed commodities, or on food contact surfaces in food handling establishments.
